

Official Facebook Giveaway Rules & Regulations

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those who are over the age of 18, living in the state of Colorado.

2. Agreement to Rules: By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of [DanceSafe Inc] as final and binding as it relates to the content of this Campaign.

3. Campaign Period: Entries will be accepted online starting 03/14/2019 on and ending 03/24/2019

4. How to Enter: The Campaign must be entered by submitting an entry using the online form provided at dancesafe.org. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of DanceSafe inc
